# RTS Transit Planning Department to Work with Consultant to Create Plan to Restore Ridership to Pre-COVID Numbers

The RTS Transit Planning Department is working with a consultant to create a plan that will help restore the number of people using public transportation to what it was pre-COVID. The plan is funded by a grant from the Federal Transit Administration (FTA). The City is currently putting together a list of people from different communities and organizations (i.e. workforce, healthcare, social, educational, and neighborhood organizations) who will help the consultant come up with ideas for how to use public transportation in the future, given changes that have occurred in school, work, and leisure transit trips post Covid-19. The planning process is expected to last approximately 9 months.

The Transit Planning Department is also developing a plan that will help make RTS the best ride in the region. This requires a Public Involvement Plan that must be approved by

the Florida Department of Transportation (FDOT) or consistent with the approved Metropolitan Planning Organization (MPTO) public participation plan.

The planning process also requires that FDOT, the Regional Workforce Development Board, and the MPO be advised of all public meetings at which the Transit Development Plan (TDP) is presented and discussed, and these entities must be given the opportunity to review and comment on the TDP during the development of the mission, goals, objectives, alternatives, and 10-year implementation program.

Finally, the plan must include an estimation of the community's demand for transit services (10-year annual projections), using the planning tools provided by FDOT or a demand estimation technique approved by FDOT.

# AssetWorks Chosen As Replacement for RTS **Current Fleetnet Software**

RTS Maintenance has chosen AssetWorks as the replacement for their current Fleetnet software. AssetWorks will provide additional functionality for both vehicle and facility maintenance, which will increase efficiency and data.

The system will also be partially integrated with Clever Devices, which offers software maintenance, system monitoring, hosting, consulting, database management, field, business intelligence, and onsite support services, to allow real-time service requests to be generated on both vehicles and facilities.

The implementation of AssetWorks will take place through 2024. As part of the implementation, every Fleet Mechanic, Parts Specialist, and Maintenance Worker will be assigned a tablet. This will allow work orders and service requests to be updated at workstations and on-site providing near real-time updates with greater accuracy. RTS Maintenance has also replaced their diagnostic laptops for increased reliability and speed.

# Pedestrian Crosswalk and Bus Shelter Upgrade by Grace Marketplace Multimodal Enhancement

When Grace Marketplace opened along NE 39th Ave, the need for enhanced pedestrian and transit facilities was identified and deemed a high priority given the associated access and safety needs of the transitdependent population seeking the facility services.

The Department of Transportation of the City of Gainesville was able to design and fund the construction of upgrades to the bus stop on the south side of the road to make it more inclusive and ADA compliant; a Multiagency effort to enhance safety for all road users resulted in a Pedestrian safe crossing enhancement implemented by FDOT in 2023.
