RTS Maintenance Team Continues to Successfully Complete Tasks for the DOT and RTS Bus Stop ADA Improvements Projects

The RTS Maintenance team continues to successfully complete its tasks for the DOT and RTS ADA Bus Stop Improvement Project around greater Gainesville. Work began on the projects in August, 2024. The project activities include updating intersection curb ramps to ADA standards, adding shelter pads to bus stops, installing new, wheelchair friendly bus shelters, and installing new concrete boarding and alighting pads.

Additional project highlights:

- The funds for these projects were supplied by Florida Department of Transportation Service Development grants, City of Gainesville development impact fees, and Federal Transit Administration Section 5307 formula grants from 2021, 2022, and 2023.
- The Transportation department partnered with Public Works department on funding and administering the contract to construct 15 bus stops and 79 curb ramps, while RTS took the lead on the design and construction of 98 bus stops.
- This project has also included surveying work and engineering design in order to ensure that adding bus stop wheelchair boarding areas doesn't impact storm water drainage structures, which could cause ponding or other overflow water issues caused by rain.
- Permits are required for work that may impede traffic flow. Our bus stops are located on roads maintained either by the City of Gainesville, Alachua County, or FDOT, so the contractors have had to obtain permits from all three.

- The Department of Sustainable Development also contributed by locating property lines and obtaining bus stop easements, particularly for stops where new shelters were installed. easements, particularly for stops where new shelters were installed.

NOTABLE LOCATIONS COMPLETED:

Arbor Park Apartments on SW 16th Avenue (across from the former Winn-Dixie) (Stop 773)

This stop was moved west to provide buses more room to merge left, and to provide room for both front and rear door bus areas to open onto an 8-foot deep boarding and alighting area. The existing sidewalk was only 5 feet wide. Providing bus length paved platforms is important at stops like this one where significant numbers of passengers get off the bus from the rear door. It also future-proofs for the advent of rear door wheelchair ramps.

Downtown curb ramps on and around SE 2nd Ave between SE 3rd St and Main St.

In this small zone there were three dozen sidewalk curb ramps which did not meet ADA standards or follow current FDOT guidance for accessibility, which includes accessibility for both wheelchairs and blind pedestrians. The new ramps include channelization to guide blind pedestrians as well as tactile surfaces where the sidewalk meets the road. Many of these ramps are within 50 feet of existing downtown bus stops and form part of the pedestrian network to and from the stops. Removing accessibility barriers in the pedestrian network around bus stops invites more customers to make more trips on the fixed-route transit system.

The Arc of Alachua County on NW 83rd St Near Santa Fe College (stop 1003)

This bus stop had a shelter which was originally installed prior to 2000 (possibly early 1990s). It was not possible to get into or out of the shelter with its outdated curb ramp using most wheelchairs. This resulted in a lot of customer complaints. The waiting area was also positioned at an angle away from the location where the bus stops on the side of the road. For these reasons, making the stop ADA accessible and replacing the old shelter (in April 2025) was a high priority at this location. There was also no existing sidewalk, so a pedestrian path was created for customers to access the bus stop platform.

Planning Department Projects Enable RTS to Meet FTA and FDOT Funding Rules and Regulations

Transit Route Restoration Plan (TRRP)

The Transit Route Restoration Plan was completed as an FTA grant-funded (Section 5307 of Title 49, United States Code) project that required recipients to demonstrate how to improve and increase transit ridership that was impacted by the pandemic.

Working with relevant community stakeholders and elected officials, the Planning Department coordinated and managed the project with consultants that developed a plan to reimagine current network to benefit service productivity and efficiency.

The goal is to enhance transit ridership by improving transit operation to provide better mobility options for residents and visitors. The plan recommends improvements to RTS routes and services which could be funded and implemented through FDOT-mandated Transit Development Plan (TDP). The report was submitted to FTA on January 27.

Transit Development Plan (TDP) FY 2025-2034

This is the FDOT-required 5-Year Update to RTS' development plan (completed in February 2025) that complies with Florida Administrative Code (F.A.C.) Rule 14-73.001, commonly called the TDP Rule. The TDP is required by the Florida Department of Transportation (FDOT) as a prerequisite to receiving State Public Transit Block Grant funds. The report represents RTS' planning, development and operational guidance document.

The previous plan was a 10-Year TDP major update that was adopted in October 2019. Due to its proximity, the TRRP provided a foundation upon which to build the new 5-year TDP update. The Planning Department managed the project by working with consultants to obtain input from stakeholders, elected officials, and the riding public. The report outlines actions to be taken by RTS in the next year and sets transit goals for subsequent years.

As a strategic plan, the TDP identifies needs in an unconstrained financial environment and, as a development plan for local transit services, the plan is consistent with community goals, reflects established leadership priorities and integrates the various community characteristics and development patterns that influence decisions and growth. Planning submitted the report to FDOT on February 13.

Fare Equity Study

Per Chapter 4, FTA's Title VI Circular 4702.1B, transit providers who operate 50 or more fixed route vehicles in peak service and are

located in an urbanized area of 200,000 or more people to conduct a fare and service analysis to ensure that transit service is provided in a non-discriminatory manner.

The analysis is conducted when the transit agency engages in a Major Service Change as defined in the agency's service change policy. For RTS this is a change of more than 5% in total Revenue Hours or Miles. Planning completed a report that describes proposed service changes for Summer 2025 because if implemented, they will result in substantial (>5%) changes in routes and span of service. These changes are compared to the level of services offered in Summer 2024. The thrust of the report is to show mitigation measures which will be adopted by the agency, based on identifiable potential disparate impacts.

There are proposed measures to address the potential disproportionate burden due to eliminated and/or reduced service levels. The report will be submitted with RTS' Title VI FY 2025-2028 Plan that is due September 30, 2025. The last Title VI plan was developed and submitted in 2022.

Certification of Ridership Data Collection Technology

Every three years, RTS conducts mandatory passenger sampling to ensure that its ridership data collection tool is providing accurate data. Presently, RTS deploys automatic passenger count technology to collect stop level, and route level ridership data which it reports to the FTA every year as part of a National Transit Data (NTD) report. Reliance on Automatic Passenger Count (APC) tool for ridership information requires confidence that its accuracy largely mimics (at least 95% confidence level) or exceeds that of human counters.

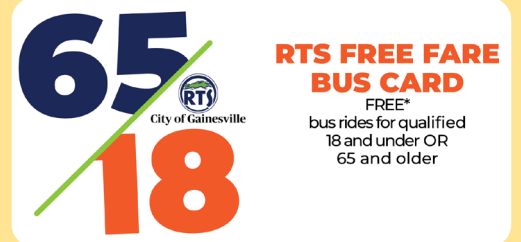
The technology uses beams of light (or temporary pictures) to count entering and exiting passengers. The mandatory sampling requirements for the certification are outlined in FTA Circular 2710.2a_1 sampling procedure for obtaining necessary Fixed Route Motor Bus Operating Data.

The certification requires sampling (long/short, weekday/weekend and day/evening service routes) and manually counting passengers and comparing the data with APC-generated ridership numbers. The variance between the two sets of data must be within acceptable levels for approval by the FTA. Upon submittal (September 2025), the approval will allow RTS to continue to use the APC software to collect ridership data.

65 and Over 18 and Under Free Fare Bus Card Available for Qualifying Applicants



The 65 and Over 18 and Under program allows eligible customers who are 18 and younger or 65 and older to ride RTS buses during regular service hours without paying a fare.

A current state issued ID is also required. Bus cards are available in digital and physical formats.

Mobility on Demand



Neighbors in East Gainesville can use the "Mobility on Demand" (MOD) service for free transportation to clinic visits, health screenings and other essential community

resources. The shuttles go door-to-door for passengers who can't walk to an RTS bus stop or need additional support to reach their destinations reliably and affordably.

The Mobility on Demand runs on weekdays from 5:30 a.m.–8:30 a.m. and 4:30 p.m.–8 p.m. Passengers can be transported to any destination within the East Gainesville MOD zone.

Residents can schedule a ride up to seven days in advance using the RTS Connect app, which is available for download on both [Apple](#) and [Android](#) devices. After the ride request is received, an RTS vehicle will pick them up at their home and take them directly to their destination at no cost. Those without access to a smartphone can also schedule rides by calling [352-393-RIDE](tel:352-393-RIDE).

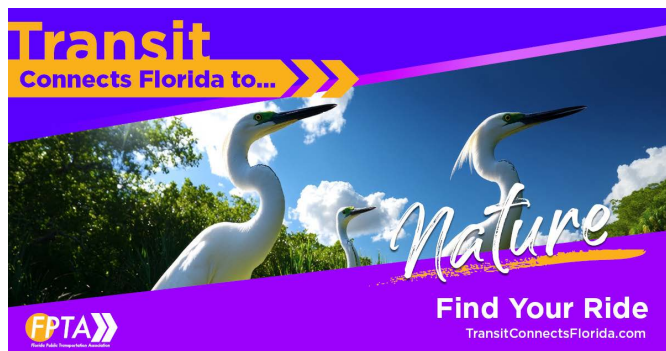

RTS Hosts 2025 Florida Triple Crown State Rodeo
