## ACKNOWLEDGEMENT

**This form must be presented with a photo to be used on the program card and a proof of age document (driver's license, birth certificate, etc). Form must be turned in at any RTS Transfer Station or Admin Building, Monday - Friday from 8 AM - 3:45 PM, excluding holidays.** The estimated processing time for forms is 2-3 weeks, during which time you will be required to pay fare.

If you chose to receive a **digital card**, you will receive account setup instructions via the email you provided. If you are 18 and under, the digital card will expire automatically the year you turn 19. For those 65+, the digital card has no expiration date and is valid for the duration of the program.

If you chose to receive a **physical card**, you will be notified when your card is ready to be picked up. **Cards may be picked up at the RTS Rosa Parks Transfer Station (700 SE 3<sup>th</sup> St, 32601), Monday - Friday from 8 AM - 3:45PM excluding holidays.**

Customer are eligible to replace their cards once every three (3) years for no cost at the RTS Administration Building. For 18 and under passengers, a new photo must be provided for the updated card. Lost or damaged cards within that three (3) year period can be replaced for \$10.00. A second replacement card within that three (3) year period can be replaced for \$20.00.

If applying for a replacement card, you must bring or mail in your application along with the required fee, photo, and proof of age document to the RTS Administration Building. Valid identification must be presented in order to obtain a replacement card.

*Program cards do not qualify as government-issued IDs and are for use on RTS fixed-route buses only. Any disruptive, dangerous, or fraudulent behavior may result in your Age-Based Farefree program pass being revoked and you may be banned from participating in the Age-Based Farefree program.*
